The contract holder agrees to abide by all rules and regulations of a Gathering of Angels and pay said fees by promotor and its agents. It is agreed that all space allocations, modifications, interpretations or enforcement of the rules and regulations as printed here are acknowledged by submission of this request for space.

Cancellations- *If you cancel prior to the 60 day period before the event you will get a full refund. Any cancellations received after the 60 day period will not receive a refund. All cancellations must be done in writing with your name and reason for cancelling.*

1. About Banners- Nothing can be hung or attached to walls. Must have table top type sign or free standing floor sign for behind table only.
2. No burning of candles, incense, sage or anything else that may interfere with services or effect guests with sensitivity
3. Set up time can start at 8:30 am. You must be fully set up and ready to go by 9:45 am. You are expected to stay the entire event time which is until 5:00 pm. If you leave early you may not be invited back for other events.
4. No animals allowed on premises- except for service animals.
5. You are an independent contractor and not an employee of a Gathering of Angels/ Spirit & Crystal Connections for any purpose. Any income taxes, royalties, fees, taxes, welfare & insurance obligations, dues are payable by you. You agree to and shall hold Gathering of Angels/Spirit & Crystal Connections harmless from any such costs, fees, expenses or taxes related thereto.
6. No hooking - the unscrupulous solicitation either inside or outside the venue by you or your helpers, you are 100% responsible for the actions of your helpers; must stay behind your table when speaking to potential clients, no calling out to them. If a complaint is lodged against you, you may be warned once and then be asked to leave with no compensation.
7. Singing bowls, drums, musical instruments and loud music are prohibited
8. No pixie/fairy dust or glitter

I will defend, indemnify and hold a Gathering of Angels/Spirit & Crystal Connections and its officers, agents, trustees and employees harmless from all injury, loss, costs, claims or damages to any person or property arising from related or in any way connected with this event enrollment.
